### Lee's Wharf's Landscaping

The developer of Brown and Howard Wharf made a deal with a city department manager to landscape the area at the end of Lee's Wharf (a CRMC right of way). This manager had no right to do so.

The landscaping included some tall yews and other shrubs that would block the view of the water at the end of the RoW. The city manager was made aware of the problem and the tall shrubs have been removed.

### **Newport City Council Resolutions**

- 1. The city council passed a resolution to name the small park at the end of Long Wharf after the founder of FoW Mary Ferrazzoli. FOW donated \$5000 to the park to help defray some of the cost associated with the necessary work to be accomplished. FOW and the Merritt Land Trust, working with FoW have each donated a bench.
- 2; The city council passed a resolution stating that anyone who removed, destroyed or covers up the CRMC plaques embedded in the streets at the head of CRMC designated right of ways shall be ticketed and subject to a fine.
